- \* No election for Dir 1-23, 3-24, & 4-24. Each will continue their elected terms.
- \*\* Dir 2-23 election is for the remainder of an unexpired three year term.
- **Nominations will be accepted from the floor** if the individual is present, eligible, and agrees to serve. Only an adult member currently in good standing who has been a member of the Society for at least one full uninterrupted year immediately preceding an election shall be eligible to stand for any elective office. Only one member of a household may be an officer and only one member of a household may be a director. Elected officers are limited to four consecutive (eight total) one-year terms. Elected directors are limited to two three-year terms.
- **Annual membership renewal is due in January.** Not sure if you already paid for 2022? Reminder emails went out on Thursday, 12/30/2021. Family membership is \$20 and single is \$15. Save a stamp and put it in the same envelope with Burns' Nicht reservations!
